The plaintiffs' motion to file the supplemental affidavit of plaintiff Newdow is granted; however, the plaintiffs must show cause in writing on or before 5 p.m. EST on Wednesday, January 14, 2009, why the Court should not exclude the representations made by plaintiff Newdow in paragraph three of his affidavit in its consideration of the merits of plaintiffs' motion for injunctive relief based upon plaintiff Newdow's failure to provide a basis for his knowledge as to the representations set forth in that paragraph. Unless plaintiff Newdow files an amended affidavit that satisfies the requirements of the Federal Rules of Evidence, the Federal Rules of Civil Procedure including Federal Rule 10(a) and the Local Rules, or otherwise shows cause prior to that time, the Court will not consider the representations in paragraph three of his affidavit.
